
### स्वीकृति आदेश/ Sanction Order - 322/2015-16

With reference to your application for financial assistance to celebrate International Day of Yoga, sanction of the Competent Authority is hereby conveyed to your organisation with a financial assistance of maximum of Rs.1.00 lakh (Rupees One Lakh only), after fulfilling the conditions as laid down in the scheme, on reimbursement basis and subject to the following terms & conditions:

1. The camp will commence from 21<sup>st</sup> May and conclude on 21<sup>st</sup> June'2015.
2. Minimum four Yoga Classes of minimum one hour duration during the month.
3. The number of people to be extended Yoga training in the camp shall not be less than 100.
4. The NGOs/Voluntary organizations may also undertake other promotional activities like; Yoga Run, Free Consultation to Public, Health Exhibition, Live display of films on Yoga, Distribution of IEC material, Sale of books on Yoga and Health etc.
5. On 21<sup>st</sup> June'2015, the grantee organization will organize a Workshop/Seminar by inviting the Yoga/Allied sciences experts. The organization shall also involve Nehru Yuva Kendra, NCC, NSS & other related organizations to the extent possible.
6. The list of participants/beneficiaries along with their details i.e. name, address, phone no. etc shall be maintained by the grantee organization, which shall be produced along with the report of the camp and programme so conducted within one month from the date of completion of programme for claiming reimbursement along with other required documents as mentioned in para 9 and 10 of the scheme.
7. The organization must ensure that all the participants compulsorily practice the techniques prescribed as per Annexure "A" of the scheme on 21<sup>st</sup> June'2015 from 7:00 am to 7:33 am.
8. The reimbursement will be made on submission of report of the Yoga Camp along with the list of participants, details of Yoga Teacher with qualification & experience, activities undertaken during the celebration of International Day of Yoga along with Photographs, grant-in-aid bill (Pre-Stamped Receipt) Utilization Certificate in the form GFR-19A (Format enclosed), Audited Statement of Accounts duly signed by the Chartered Accountant & Counter Signed by the Authorized Signatory.
9. Bank Details (Name of Bank and Branch, Accounts No., RTGS/NEFT Number, IFSC Code, Name of the Accounts holder) for reimbursement of grant-in-aid.
10. The Institution may submit a certificate that no Grant in-aid/Financial Assistance has been received for the same purpose or activity from any other source(s).
11. The grant-in-aid will be released after submission of accounts for 2014-15.
